WHAT'S HAPPENING IN CALIFORNIA



CDHA's Legislative Day was a great success!
28 hygienists from all over the state visited at least 33 legislators to inform them:

1. Dental Hygienists are an educated health care workforce which could be utilized more to address California's needs in more health care settings, under less supervision.
2. Dental hygienists specialize in preventive oral health care services, in particular periodontal disease treatment and prevention, which improves overall health thereby lowering health care costs for both patients and the state.
3. Denti-Cal changed its policies in 2016 for approval of periodontal disease treatment and maintenance, as well as slashing reimbursement rates, resulting in denied oral health care for patients and the loss of Denti-Cal RDHAP providers.

Senator Anthony Canella was presented with the CDHA Legislator of the Year Award for his commitment to a healthier California, improving

voluntary, non-partisan, political advocacy committee.

Department of Health Care Services (DHCS)

- CDHA continues to advocate for the inclusion of CDHA and dental hygienist advisors to DHCS
- The CDHA Government Relations Council (GRC) and Alternative Practice Council (APC) developed a Position Paper on recent DHCS actions. [CLICK HERE](#)

Labor Laws and Employee Rights

- GRC has arranged for a Labor Commissioner lawyer to present at HOD in San Diego

Dental Hygiene Committee of California

- DHCC has corrected DHCS' misconception that caries risk assessment is not in the DH scope of practice and CDHA is working to have Department of Health Care Services accept and reimburse hygienists as providers of the assessment.
- Interim Therapeutic Restorations (2015- AB 1174)-initial regulatory language is being drafted in collaborations with DBC

Dental Board of California

- **Pre-approval for Mandatory CE courses- Infection control and CA Law courses are to be pre-approved by DBC, in addition to having CE provider approval.**
- **It is the licensee's responsibility to ensure the classes they take meet all necessary CE qualifications.**
- **Suspension of RDA Practical Examination effective until July 1, 2017 at which time it will be reinstated. Applicants who have not taken or have not successfully passed the exam, but meet all other requirements, will be licensed.**

WHAT'S HAPPENING NATIONALLY

Bills into Law



- Florida- Senate Bill 580 authorizes reimbursement to health access settings for children's dental services provided by licensed dental hygienists.
- Illinois- House Bill 5948 reduces additional course work for public health dental hygienists from 72 to 20 hours. It also

allows a public health dental hygienist to treat patients without a dentist first examining the patient and being present in the facility during treatment.

- Maryland- House Bill 470 authorizes, subject to requirements, dental hygienists to administer nitrous oxide to patients under the supervision of a dentist who is physically present on the premises and who has prescribed the administration of nitrous oxide.
- Missouri-Senate Bill 579 specifies the licensed individuals who shall be considered eligible health care providers for the provision of telehealth services.
- South Dakota-House Bill 1104 allows a dental hygienist to continue providing services after 13 months, as long as the patient receives an "oral health review."
- Tennessee-Senate Bill 1214 authorizes the practice of "teledentistry."
- Utah-Senate Bill 147 makes technical changes clarifying that dental hygienists working with a collaborating dentist are able to perform services remotely in a homebound patient's residence, a school, an nursing home, and assisted living facility, a community health center, a federally qualified health center and a mobile dental health program that employs a DDS.
- Virginia-Senate Bill 712 expanded the Remote Supervision Public Health Model for the dental hygienist employed outside of Virginia Health Department.

Recent Legislation



Aaron Read & Associates is tracking 20 bills for CDHA as of April 7, 2017.

Legislation supported by CDHA include:

SCR 19 (Nguyen) Periodontal Awareness Month-cosponsored by CDHA and California Society of Periodontists passed without opposition and establishes March as Periodontal Awareness Month in California.

Assembly Bill (AB) 15 (Maienschein) Denti-Cal Program-would double Denti-Cal reimbursement rates for 15 most common prevention, treatment, and oral evaluation services, based on average rates established in fiscal 2-15-16, effective January 1, 2018. The funding comes from the Prevention Tobacco Tax Act of 2016.

AB 753(Caballero); Denti-Cal improved access.

Senate Bill (SB) 300 (Morning) Sugar sweetened beverage health warnings -would require health warning labels on sugar sweetened beverages.

SB 379 (Atkins) Pupil Health- would facilitate and improve kindergarten oral health data collection.

SB 707(Canella) Medi-Cal: Denti-Cal Advisory Group

Legislation opposed by CDHA:

AB 387 (Thurmond) Minimum Wage-mandates minimum wage for allied health care" interns" and defines "employer" in a manner that would negatively impact many allied health programs including dental hygiene.
